- Enroll electronically

- View and change investment option elections for future contributions
- View daily and monthly unit values
- View investment performance
- Model and initiate plans loans (if applicable)
- View pending transactions
- Manage personal profile information

## Registration

1. Go to [www.accountservices.aul.com](http://www.accountservices.aul.com).
2. Click on "Register Now".
3. Complete the step-by-step registration process, which includes:
  - Creation of User ID and Password
  - Creation of password recovery information

## Enrollment

1. Enter your User ID and Password created during Registration. Click Login.
2. Complete the step-by-step enrollment process, which includes:
  - Entry of deferral information
  - Entry of beneficiary designations
  - Investment selection
  - Information regarding account consolidation (if applicable)
