The fund invests primarily in equity securities, specifically, common and preferred stocks, convertible securities, rights and warrants to purchase common stock and depositary receipts. It invests, under normal circumstances, in issuers located in at least three different countries, including the U.S. The fund emphasizes investment in issuers in the U.S. and in the developed countries of Western Europe and in the Pacific Basin and may also invest up to 20% of its total assets in issuers located in developing countries.


